Créée en 1979, la Fédération française des ports de plaisance (FFPP) est l'organisation professionnelle reconnue par les pouvoirs publics pour représenter les gestionnaires de ports de plaisance maritimes, fluviaux et lacustres au niveau national.

Au travers de ses 8 unions régionales constitutives, la FFPP fédère plus de 450 ports de France hexagonale et ultramarine.

Les ports de plaisance français accueillent plus de 4 millions de plaisanciers au travers de leurs 250.000 places de port et génèrent un chiffre d'affaires de plus de 600 M€. Les effets économiques indirects et induits sont estimés à plus de 8 milliards d'euros.

La FFPP et L'UPACA sont à l'origine des certifications « ports propres » et « ports propres actifs en biodiversité », premiers référentiels mondiaux de gestion environnementale des ports de plaisance.



Surveys and Diagnostics an essential step ...

- 1. Inventory :
 - *port / watershed / marine area*
- 2. Pollution sources are graded
- 3. Plan of actions in a proportional way
